6. The **Transaction Code** must be A, C, or D. For the original transmission, only A is valid. For subsequent batch/update submissions, if A is specified then the record must not already exist on the data base; if C or D is specified then the record must exist on the data base. -record rejected-

7. Each WDIS Student End of Term Status record must be unique based on the keys of **District Number, Current Instruction/Service; Student Number Identifier, Florida; Survey Period Code; WDIS Reporting Year; Prior Year,** and **Grade Level.** If more than one WDIS Student End of Term Status record is submitted for a student, only one record with **Grade Level** = 09-12 will be accepted and only one record with **Grade Level** = 30 or 31 will be accepted. -record rejected-

10. **(REVISED 1617) Florida Education Identifier (FLEID)** is alphanumeric and must be entered as "FL" in the first 2 positions followed by twelve numeric digits **and must be greater than FL00000002000**. No blanks or spaces are allowable. -record rejected-
