Comments: The greatest strength of this submission is the overall design and engagement the product inspires. It is easy to navigate with intuitive controls and progression through the content. The embedded multimedia and clickable content is likely to keep the interest of both students and teachers. It is the best that I have seen so far in digital content in this regard. Teachers with practice should be able to make the best use of the product in only a year or two. The only concerns I would have are that some standards might require a bit of improvement within the content and I worry about low level learners being able to access fully the content even with adaptations. However, it is always my opinion that students should be challenged and supported as opposed to the opposite. Last, the My DE resources, ability for students to interact in forums or to blog, and the high interest activities make this product ideal for 21st Century learners.
