Immature red blood cells in the marrow do have nuclei and, in cases of certain maladies, immature nucleated red blood cells may make their way into the peripheral blood. Again, I don't like making pat absolutes in science.

Describes structure and function of erythrocytes but only refers to them as red blood cells. Lists various neutrophils, but does not give individual white blood cell functions or platelet function. Speaks about Antigen-Antibody (Ag-Ab) Response and gives a perfunctory description of the function of plasma.

9. **SC.912.L.14.35:** Describe the steps in hemostasis, including the mechanism of coagulation. Include the basis for blood typing and transfusion reactions.

Speaks of ABO/Rh typing and percentages, also about Ag-Ab Response and agglutination, but makes no mention of normal clotting pathways, nor homeostasis. Does not discuss what blood types can be safely transfused for patients of various blood types.
