Turnaround Option Plan—Step 2 (TOP-2) Closure

Purpose

The purpose of this document is to guide districts to develop a plan for implementation of the turnaround option Closure (RC). The district shall provide the Department with this plan for approval by the State Board of Education (SBE).

Assurance 1: Close and Reassign Students

The district shall close the school and reassign students to higher-performing schools with a "C" or higher in the district. A new school does not qualify since it does not have a record of performance.

The district shall ensure that students are not assigned to instructional personnel rated as Unsatisfactory or Needs Improvement based on both the three-year aggregated state Value-added Model (VAM) rating, if applicable, and the district evaluation system.

Description of how the district will address Assurance 1: Close and Reassign Students

The district shall close the school and reassign students to higher-performing schools in the district. The Demographics & Enrollment Planning Department will assign students to high performing schools within close proximity to their home. Several options (shown below) will be shared with the impacted community as per district policy in order to get input for student reassignments.

The district will also make sure the students are assigned to teacher(s) rated "Effective" or "Highly Effective".

Assurance 2: Monitoring Reassigned Students

The district shall monitor the reassigned students and report their progress to the department for three years on a quarterly basis. Reports shall include attendance, grades and progress monitoring data aligned to Florida's Standards, the type of intervention and instruction provided to students to address deficiencies (if applicable), as well as the record of all instructional personnel assigned to the students (three-year aggregated state VAM rating, if applicable, and district evaluation rating). The district shall provide quarterly reports to the RED.

Description of how the district will address Assurance 2: Monitoring Reassigned Students

The district shall monitor the reassigned students and report their progress to the Office of School Performance & Accountability, Demographics & Enrollment Planning Department, and Student Assessment & Research Department for three years on a quarterly basis. Reports shall include attendance, grades, and progress monitoring data aligned to the Florida Standards. All Broward County students reassigned through the closure of Larkdale Elementary School will be identified and monitored through student support database, BASIS, (Behavioral & Academic Support Information System) the district's student data monitoring system.

Assurance 3: Reassignment of Instructional Personnel and Administrators

The district shall ensure that instructional personnel rated as Unsatisfactory or Needs Improvement based on the three-year aggregated state VAM rating are not reassigned to other School Improvement (SI) schools within the district.

 \boxtimes The district shall ensure that administrators from a school closed through selection of this turnaround option are not reassigned to other SI schools within the district.

Description of how the district will address Assurance 3: Reassignment of Unsatisfactory Instructional Personnel and Administrators.

The district shall ensure that teachers rated as "Unsatisfactory" based on the three-year aggregated VAM rating are not reassigned to other TS&I and CS&I schools within the district. Transfers of the aforementioned teachers to non-DA schools will be in accordance with SBBC Policy 4006 and the Collective Bargaining Agreement with the Broward Teachers' Union and the School Board of Broward County. The district shall also ensure that administrators from a school closed through selection of this turnaround option are not placed at other TS&I and CS&I schools within the district.

Per SBBC Policy 4006, the Board authorizes the Superintendent to transfer noninstructional personnel when he/she deems such transfer to be in the best interest of the Broward County Public School System.
