## Main Menu

Welcome to the main registration page for the Career and Professional Education (CAPE) Career-themed Courses. This system is only for the registration of Career-themed Courses. All Career-themed courses must be registered each year. Courses may be registered individually or by submitting a batch file. Registration of career-themed courses through which students earn CAPE Industry Certifications and CAPE Acceleration Industry Certifications is required for funding in the FEFP.

Districts are allowed to register both **Secondary** courses and **Dual Enrollment** courses. **Dual Enrollment** courses must be registered separately. See headings below to locate these sections.

Within both **Secondary** and **Dual Enrollment**, two methods are provided for registration:

- 1. Batch Upload Registration**

Use this method to upload multiple Career-themed courses from multiple schools. See Section I for instructions.

- 2. Individual Course Registration**

Use this method to register courses one-at-a-time. See Section II for instructions.
