SUBJECT: Approval of District Turnaround Option Selections

PROPOSED BOARD ACTION

Approve turnaround options submitted by school districts on behalf of failing or persistently low performing schools for potential implementation in 2014-15.

AUTHORITY FOR STATE BOARD ACTION

Section 1008.33, Florida Statutes

EXECUTIVE SUMMARY

In the first full school year after a school declines to a grade of "F," or earns a grade of "F" or "D" followed by a grade of "D," (i.e., FD or DD), the school district must select a turnaround option for that school. The turnaround options available to a school district are district managed turnaround, closure, charter, external operator and hybrid.

Turnaround option selection forms (TOP-1) have been submitted to the Department for 123 schools in 24 districts. Of these schools, 122 are elementary, middle or combination schools that will be required to implement the option in 2014-15 if their 2013-14 school grades do not improve; the remaining school is a high school that is required to implement in 2014-15 based on its 2012-13 school grade failing to improve.

The full implementation plans (Form TOP-2) for the selected turnaround options will be submitted to the State Board for approval in September 2014 after 2013-14 school grades are released.

Statutory Requirements for Turnaround Options

Pursuant to Section 1008.33, F.S.—

(4)(a) In the first full school year after a school initially earns a grade of "F," the school district must...select a turnaround option...and submit a plan for implementing the turnaround option to the department for approval by the state board. Upon approval by the state board, the turnaround option must be implemented in the following school year. (b)...the turnaround options available to a school district are:

- 1. Convert the school to a district-managed turnaround school [DMT]
- 2. Reassign students to another school and monitor the progress of each reassigned student [Closure]
- 3. Close the school and reopen the school as one or more charter schools... [Restart]
- 4. Contract with an outside entity... [Restart]
- 5. Implement a hybrid of turnaround options set forth in subparagraphs 1.-4. or other turnaround models that have a demonstrated record of effectiveness. [Hybrid]

(5) A school that earns a grade of "D" for 3 consecutive years must implement the district-managed turnaround option pursuant to subparagraph (4)(b)1.

Turnaround Option Selection, Planning and Implementation Timeline

- **February 14, 2014** districts were notified of the requirement to submit a turnaround option selection (Form TOP-1)
- May 16, 2014 Form TOP-1 submission deadline
- June 17, 2014 Turnaround option selections (Form TOP-1) submitted to the State Board of Education (SBE)
- September 23, 2014 Turnaround option plans (Form TOP-2) submitted for SBE approval for schools required to implement a turnaround option based on 2013 school grades for high schools and 2014 school grades for elementary and middle schools.

Summary of Selected Turnaround Options

- 126 schools in 24 districts required to select a turnaround option
 - o 121 selected DMT
 - 2 selected closure and will repurpose the schools under a new school identification number
 - o **3** are opting for School Improvement Rating in 2013-14; no longer subject to s.1008.33
