### The Gilder Lehrman National History Teacher of the Year Award

The National History Teacher of the Year Award recognizes outstanding K–12 American history teachers across the country. The National History Teacher of the Year is chosen from finalists in each of the fifty states, the District of Columbia, Department of Defense School and U.S. Territories. Each state winner receives a \$1,000 prize, and the National History Teacher of the Year will receive a \$10,000 prize and a trip to the awards ceremony in New York City. The recruitment, harboring, transportation, provision or obtaining of a person for labor or services, through the use of force, fraud or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, slavery or a commercial sex act.

School librarians are encouraged to take part in the program and submit their students' votes. SSYRA resources will also be available to anyone who wants them. ## Literacy

### What is “Authentic Text”?

#### **(–and why should I use it in my classroom?)**

Many terms swirl around the efforts to improve student performance and prepare them for college and career. One such term is “authentic text.”

Authentic text may be thought of as any text that was written and published for the public. Journal articles, blog posts and novels are just a few examples.

Authentic texts are written for “real world” purposes and audiences: to entertain, inform, explain, guide, document or convince. In fact, authentic texts need not even be written words. Audio files, virtual tours, speeches, blueprints, photos, video clips and other non-written items that can be read or interpreted are also considered to be text.

In contrast, most of what students read in school is written for the purpose of student instruction at the student’s grade level, and is intended to provide content in a clear and accessible manner. Thus, most are heavily structured through headings, subheadings and bullets, often starting with an overview and ending with review questions. Use of graphic devices such as photos, diagrams, white space and bold or italic font help to draw the student’s attention to important points. Vocabulary and sentence structure are controlled to support comprehension.

The problem is that students who have been exposed only to instructional text are unprepared for the kinds of materials they must confront beyond school, such as academic journals, contracts, tax forms and instructions, technical manuals, student loan applications, consumer reviews or news reporting and analysis. In order to ensure our students are prepared to graduate ready to face the challenges before them, they must have the skills and strategies to independently grapple with a variety of formats and purposes as well as a range of kinds of prose structure and vocabulary.

## Gifted

### Procedures for K-12 Gifted Education Referral, Evaluation and Services

In Florida, school districts evaluate students for gifted services and provide gifted support services from kindergarten through grade 12. Students may be referred for testing starting in kindergarten. Anyone may refer a student including parents, guardians, educators or other community members. Referrals are submitted to the school district, and the district will share the procedural safeguards and district procedures to ensure parent or guardian participation in the process.

A student is eligible for gifted services if he or she meets the state eligibility requirements including exhibiting an I.Q. score of 130 or higher, a need for gifted services and gifted characteristics. Some districts have alternate plans for determining eligibility for students.

Districts determine the format for serving gifted students starting in kindergarten based on the district’s program policies and procedures and the student’s individual needs. The student’s plan for gifted services is documented in the student’s education plan (EP). Education plans are created to highlight the gifted student’s strengths and set goals for continued support. EPs are renewed at least every three years and during transitions to new school sites (beginning middle school and high school or moving from one school to another). If a student is gifted and has a disability, the student is considered twice exceptional (2e) and the gifted plans will be a part of the individual education plan (IEP); the IEP procedural safeguards apply.

1. Rule 6A-6.0331, Florida Administrative Code (F.A.C.), establishes requirements with regard to the identification, location, evaluation and provision of a free appropriate public education for students both with disabilities and who are gifted. The requirements apply K-12 with regard to the gifted population.
2. Rule 6A-6.03313, F.A.C., sets forth procedural safeguards for students who are gifted.
3. Rule 6A-6.03019, F.A.C., establishes minimum eligibility requirements for gifted support services in Florida.
4. Rule 6A-6.030191, F.A.C., describes the development of educational plans for exceptional students who are gifted.
5. Rule 6A-6.03311, F.A.C., Procedural Safeguards and Due Process Procedures for Parents and Students with Disabilities.

## **Technology**

### **Mind Mapping Tools**

Teachers have been using graphic organizers in the classroom to engage students in deeper levels of thinking for years/decades. The benefits of using them are well documented. Now these tools are available for use by teachers and students in an interactive format to increase student engagement and knowledge retention.

There are many excellent, interactive mind mapping tools available such as Webspiration Classroom, Popplet and Bubbl.us. Some tools such as Popplet provide limited free access with the option to subscribe to get more advanced features. Other more sophisticated tools such as Webspiration Classroom are designed to be used as a platform for collaboration and assessment of critical thinking. Teachers and administrators should investigate these tools to determine appropriate uses in the classroom. Some considerations to be made include the age of the students, the cost of the product and interoperability across various platforms.

Below are some suggestions for using interactive mind mapping tools across content areas.

ELA Students can create an interactive Venn diagram to compare and contrast two characters from a specific novel or genre.

Mathematics Teachers can have students create flowcharts detailing the steps of solving a math problem. Students can present their final products to the class.

Science Students can get into groups and develop cause-effect diagrams to demonstrate the final outcome of classroom science experiments.

Social Studies Teachers can allow students to create timelines or flowcharts explaining the events leading up to key historical events.

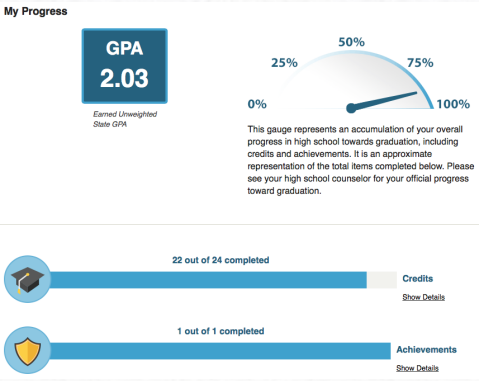
