FAU-St. Lucie's goals focus on increasing students' ELA learning gains and bridging the gap between student subgroup performance. Professional development in reading instruction is one area that the allocation supports, including teacher participation in such opportunities as the FRA Conference, Just Read, Florida! trainings, and Reading Horizons coaching sessions. Salaries for two, full-time reading coaches and a part-time elementary reading interventionist are funded through the reading allocation, as well as two Reading Horizons phonics kits to be used for intervention purposes. The professional development opportunities, coaches,

interventionist, and resources will assist teachers in implementing high-yield, effective reading instructional strategies, tracking student progress, and monitoring students' responses to instruction, which will lead to increased student achievement. Additional, differentiated reading materials and research-based intervention program materials will be purchased using separate funding sources.

- Supplemental instructional materials that are grounded in evidence-based reading research; and
- Intensive interventions for students in kindergarten through grade 12 who have been identified as having a reading deficiency or who are reading below grade level as determined by the statewide, standardized English Language Arts assessment.

## APPENDIX B

### **Identification of Students with Reading Deficiencies and Intervention Supports**

In this section districts will describe how they identify students with substantial reading deficiencies and provide them with required interventions. Districts will create three Identification/Intervention Decision Tree charts to demonstrate how data from screening, diagnostic, progress monitoring, local assessments, statewide assessments or teacher observations will be used to determine specific reading instructional needs and interventions for students. It is important to note that a school may not wait for a student to receive a failing grade at the end of a grading period to identify the student as having a substantial deficiency in reading. If a local assessment is being used for identification, districts should internally analyze their data in order to ensure students are identified at similar rates as on statewide assessments. Districts who use a procured diagnostic, progress monitoring or assessment tool should, at a minimum, use the recommended ranges provided by the instrument developer; however, these districts should also ensure that rates of identification correlate to statewide performance.

- DT1 – Elementary (K-5)
- DT2 – Middle (6-8)
- DT3 – High (9-12)

The charts must contain the following information:

- The grade level(s) of the student;
  - Name and performance benchmark on screening, diagnostic, progress monitoring, local assessment, statewide assessment or teacher observations used to identify students with substantial deficiencies in reading and subsequent interventions provided. FSA-ELA scores must be used for appropriate grade levels;
  - DT1 must clearly state the conditions the district uses to determine whether a student has a substantial reading deficiency and will subsequently notify the student's parent as required in Section 1008.25, F.S. This also includes a description of the intensive, explicit, systematic and multisensory reading interventions which will be provided to students in grades K-3;
  - DT1 must include information on how the Florida Kindergarten Readiness Screener will be used to identify students for intervention. For each grade level on each chart, districts must include a description of which students will be reported in the Student Information System with an appropriate code for the Reading Intervention Component; and
- An explanation of how instruction will be modified for students who have not responded to a specific reading intervention with the initial intensity (time and group size) provided;

  - Per Florida Statutes 1008.25, students receiving Tier 2 interventions that are not making adequate progress in closing the achievement gap will be determined as having a substantial reading deficiency and will be referred to the PST to determine an appropriate intensive reading intervention during MTSS with Tier 3 interventions and/or the following criteria:
    - Below the 15<sup>th</sup> percentile on iReady
    - Below 20% on SLPS Unit Assessments
    - Level 1.1 on FSA
    - Below a scale score of 218 on FLRKS
