## SUBJECT: 2020-21 Data Submission Cycle: Community Based Organizations Adult General Education

The purpose of this memorandum is to inform you of key dates in the data reporting cycle and highlight validation reports you should review to ensure that the data you report to the state is accurate. Your data is used for state and federal funding, and accountability purposes and it is critical that it is complete, correct and reported on time. The best approach to quality assurance is collaboration between program and Management Information Systems (MIS) staff. To that end, you should be aware of all data submission timelines and when to review reports to identify errors before the submission windows close.

Below you will see the current data submission timetable for the 2020-21 reporting year. These dates are subject to change; any revisions will appear in Appendix F of the 2020-21 Community Based Organizations (CBO) Handbook, which can be obtained by email from Nand Divate at: nandkumar.divate@fldoe.org.

Workforce Education Data Systems (WEDS) produces an edit or validation error report if errors are found for CBOs during each submission period. These reports reflect what your CBO reported to the state during the survey submission period and will stipulate any specific data inconsistencies to be corrected and resubmitted to the Department of Education. The designated contact in your MIS unit should provide you with these reports for your review before each survey submission period closes.

Please consult with your local MIS staff regarding internal reporting deadlines that need to be met. Lastminute data submissions and updates may place a workload burden on local staff.
