SUBJECT: Perkins IV 2013-2014 Local Level Data Review

The Perkins IV 2013-2014 Consolidated Annual Report (CAR) collects state annual enrollment, performance accountability and financial status reports on the Perkins State Basic Grant (Title I), as authorized by the Carl D. Perkins Career and Technical Education Act of 2006, 20 U.S.C. 2301 et seq. as amended by P.L. 109-270 (Perkins IV or the Act).

In order to ensure data reliability, a website has been developed that will facilitate local review of 2013-2014 Perkins IV data. As a reminder, states and locals are accountable for all postsecondary (college-level and adult-level) measures during 2013-2014 as delineated in the charts below:

In order to access the Florida Department of Education Perkins IV CAR Data tool, go to https://app1.fldoe.org/PerkinsData/DataTool.aspx. To view data, select 2013-2014 from the drop-down menu, select agency type and then your agency. You can then click on the "submit" button which will produce data results. The results include the numerator, denominator and calculated percentage for all of the performance measures. The tool includes an option to view state-level data on all measures as well.
