## SUBJECT: Updates to Lower-Division Career and Technical Education Program and Baccalaureate Classification of Instructional Programs Codes for the 2021-22 Reporting Year

As many of you know, the National Center for Education Statistics (NCES) Classification of Instructional Programs (CIP) provides a classification system for postsecondary programs for tracking and reporting purposes. NCES published updated federal six-digit CIP codes for 2020, which reflect the various programs of study being offered at postsecondary institutions around the country. Also, last year, the Division of Florida Colleges and the Division of Career and Adult Education coordinated a parallel external stakeholder review for baccalaureate degree programs and lower-division career and technical education (CTE) program codes.

With regard to the codes related to baccalaureates, the external stakeholder review both affirmed federal 6-digit CIP assignments and identified standard occupational code (SOC) linkages with the goal of identifying CIP to SOC linkages at the upper-division level. The lower division CTE external stakeholder review only identified appropriate federal 6-digit CIP assignments, and a separate CIP to SOC linkage review for lower-division CTE programs will be initiated later this year.

For your planning purposes, we have attached a consolidated workbook that contains the following CIP codes which will be effective for the 2021-2022 reporting year, as a result of the reviews.

- 1) Tab 1 the 2010 to 2020 Baccalaureate CIP Crosswalk (applicable to Florida College System (FCS) institutions only)
- 2) Tab 2 the 2021 Baccalaureate CIP to SOC Crosswalk (applicable to FCS institutions only)
- 3) Tab 3 the 2010 to 2020 Lower Division CTE CIP Crosswalk (applicable to both FCS institutions and school district technical colleges)
