## Colleagues:

Through our continued partnership with the Florida Association for Career and Technical Education (FACTE) and CareerSource Florida, the Florida Department of Education is pleased to build upon the momentum of apprenticeship growth in Florida, with the announcement of a second initiative supported by the federally funded **Apprenticeship State Expansion (ASE) Grant.** We are pleased to inform you that grant information is now posted on the <u>Apprentice Florida</u> website.

These federal ASE funds, in conjunction with our recently awarded Pathways to Career Opportunities Grant Program, aim to expand existing registered apprenticeship programs. The grant funds support our goal to become number one in workforce education by 2030.

The ASE Grant supports two mini-grant initiatives: 1) the previously announced "Program Grant" and 2) with this announcement, the addition of the ASE "Participant Support Grant". The "Participant Support Grant" consists of \$700,000 in funding to support 1000 apprentices. Individual awards up to \$700 to Registered Apprenticeship Programs in support of eligible apprentices.

- Programs must have active apprentices who are fully registered with the Florida Department of Education or after July 1, 2019.
- At the time of the application, the apprentices must have completed their probationary period or 90 days in the program, whichever is less.
- The registration date of the program is not an eligibility factor for this funding.
- There is no limit on how many \$700 awards a program may apply for.
