The Bureau of Community College and Technical Center Management Information Systems (CCTCMIS) announces the collection of exclusions data for the 2023-2024 IPEDS Graduation Rate Survey. This survey includes a three-year look at completions and graduation rates.

For the exclusions data collection, which begins on Friday, October 6, 2023, colleges will provide a file containing exclusion type and student data from the Fall 2020-2021 cohort. The format and instructions for the exclusions file are attached.

Please submit the exclusions file with the exclusion type and students' identification numbers using the filename CCxx.STU.EXCLUDE2.T2B2021.PROD.txt (where xx is the institution number). Submit the certification form and indicate "No" on the form if your college has no students meeting exclusion criteria in the cohort.

The exclusions file data submission is due Friday, November 3, 2023. The certification form is available on the <u>CCTCMIS website</u> and must be submitted by Monday, November 6, 2023, using the specified certification file name listed within the form.

### <u>Two Year Cohort</u>

The Fall 2020-2021 cohort file, CCxx.STU.EF2IPFIL.T2B2021 (where xx is the institution number), has been sent to your college via TIBCO<sup>®</sup> by the Bureau of PK-20 Education Reporting and Accessibility (PERA). Download the file to a secure area.

Select records where:

Line = 1 Full-Time\First-Time Degree\Certificate Seeking

and Gender not equal to "X" (unknown gender is not reported to IPEDS)

## **Exclusions**

Include **ONLY** those records of students from the Fall 2020-2021 cohort who meet one of the following criteria:

- a. The student is deceased or is totally and permanently disabled and thus unable to return to school.
- b. The student left school to serve in the armed forces or was called up to active duty (Do NOT include students already in the military who transfer to another duty station).
- c. The student left school to serve with a foreign aid service of the federal government, such as the Peace Corps.
- d. The student left school to serve on an official church mission.

Include all exclusions from Fall 2020-2021 through, and including, Summer 2023-2024.

Return the exclusions file to Community College and Technical Center Management Information Systems (CCTCMIS) with the student identification numbers of the exclusion-eligible students, if any, using the following file naming convention:

CCxx.STU.EXCLUDE2.T2B2021.PROD.txt (where xx is the institution number)

**NOTE:** Files with invalid filenames will be rejected and deleted.

If your college has no exclusion-eligible students in this cohort, please send the certification form only and indicate "No" on the form.

The exclusions files are due by Friday, November 3, 2023, and the completed certification form is due by Monday, November 6, 2023.

Records not in the original cohort will not be loaded.
