

School Environmental Safety Incident Reporting (SESIR)

School Environmental Safety Incident Reporting (SESIR)

SESIR incidents can occur 365 days/24 hours! SESIR incidents can involve students, non-students, or unknown offenders.

- <u>6A-1.0017, Florida Administrative Code</u> (Updated 8-16-2021) School Environmental Safety Incident Reporting (SESIR) Rule
- Section 1006.07(9), Florida Statutes District school board duties relating to student discipline and school safety
- Section 1001_212(8), Florida Statutes Office of Safe Schools
- All SESIR incidents must be reported! Per Policy 5500, incidents that must be reported to law enforcement include all Zero Tolerance offenses: Arsor; Aggravated Battery on Specified Official or Employee (charged); Biological/Chemical Attack or Threats; Bomb Threats/Explosives; False Reports; Firearms; Fireworks, Major; Homicide/Murder; Kidnapping/Abduction; Robbery; Sexual Battery; Threat/Nitribidion on Specified Official or Employee (charged); Threatening Use of Dangerous Instrument; Threats Relating to Discharge of Destructive Device; and Weapons Possession.

- FL DOT Rank Order for SESIR Incidents (Updated 8-19-2020) FL DOE's ranking order of the Incident Type Level are identified in the first column of Appendix P. Definitions for incident Reporting. Appendix P notes on the last page, "The Incident Type Level column provides a preliminary rank order of incident types for school reporting with Level 1 being the most serious and Level IV being the least serious. If a decision must be made between two incident types, the incident that caused the most injury or the highest loss of property of monetary cost should be reported." If "the most injury or the highest loss of property or monetary cost are not relevant to the incident, base your decision on whatever describes the situation the best or what is most significant. Therefore, the highest ranking or the incident with the most injury, highest loss of property or monetary cost, or the best or most significant will be recorded in Skyward and the other offense will be noted in the comment box. Also, if appropriate, the Other Related codes would be recorded.
- <u>Other SESIR Defined</u> Please review this document to see how Other SESIR Defined is used. With all SESIR offenses, the state is looking for a
 discipline resultant action code (i.e., out-of-school suspension (ISS/PASS)). For some offenses, a school may not give an
 OSS or ISS/PASS; however, may give something else like School Plus. In this situation the school will record two action codes in Skyward: School Plus
 (013) and Other SESIR Defined 052.) Under SESIR Defined can only be used with six (6) specific action codes; therefore, please review the document
 link to see which six actions may be used.
- Look Fors in SESIR Discipline Data in Skyward (Updated 8-18-2022) This document will assist schools in recording accurate SESIR data in Skyward. Please remember that what the schools submit to Skyward will also be sent to DOE in Survey reports.
- <u>Student Discipline Shortcut</u> (New 9/1/2022) This document is a one-page resource with links to various areas on our Google site involving student discipline.
- How to Record Vaping: Related in Skyward Beginning the 2020-21 school year, FL-DOE added a new element called, Incident, Vaping: Related. An
 incident is vaping related if it involves the use of non-combustible vaping products, including electronic cigarettes, vapes and vape pens, or any
 electronic nicotine delivery system (ENDS) are required to be reported as Vaping:related, if the liquid used contains nicotine or a controlled
 substance. Schools are not required to test for nicotine or drugs in vaping devices. Schools will record this code in addition to the tobacco or drug
 possession/use if it meets the definition defined above.
- How to Record Offense Setting in Skyward Beginning the 2020-21 school year, FL-DOE added a new element called, Incident, Setting. The code must be used for incident types of Bullying, Harassment, Sexual Harassment, Threat/Intimidation, Unsubstantiated Bullying, Unsubstantiated Harassment and for incidents coded for Incident, Bullying, Related. If any of these offenses are entered in Skyward, schools will mark if the offense was committed in person (in the presence of the targeted individual) or if the offense was committed remotely (electronically or through any other means).

The above document is in a folder designated for each school. On a weekly basis, two people from the Choice and Alternative Education Department reviews the SESIR Dashboard identifying possible errors. Errors may include:

- Multiple people involved in the same incident where the school has entered multiple incident numbers instead of just one incident number that involves multiple students.
- School may have entered an offense that may not match the SESIR definition in the Code of Student Conduct & Policy Guide. An email is sent to the District's Safety and Security Supervisor for a review of the incident described in the Student Information System. If the incident needs to be reviewed by the school, an email is sent to the discipline officer.
- Various other aspects that need attention by the school.

The Administrator Coordinator emails the discipline officer(s) with a link to the Hub on the right. The school will be able to see information to assist in making corrections to an incident with support from our department. School administrators and data clerks have access to their school's folder.

Purpose: SESIR Rule 6A-1.0017, Florida Administrative Code, states that each public school principal, including charter school principals or equivalent, must ensure that all persons at the school responsible for SESIR information participate in the training set forth in the rule and must ensure that SESIR data is accurately and timely reported. Section 1006.07(9), Florida Statutes, states that the superintendent is responsible for school environmental safety incident reporting including ensuring the accuracy and timely reporting of incidents related to school safety and discipline. Failure to comply is subject to the penalties specified by law.


General Tips	SESIR Definitions	Recording Details of Incident	Required Law Enforcement
 How do I review the Dashboard to determine if our school has possible data entry errors? What am I looking for? How do I analyze my data? Look at the incidents that are noted in this SESIR Virtual Lab Hub. If you have any of these incidents, make sure you have recorded all of the required elements noted in this document. Multiple students involved in the same incident - This ink will provide tips for which incidents need verification. The IT Department has created a document to give you assistance with the most common edits, validations, or exceptions involving Discipline and SESIR for Survey R document. 	Once the incident has been investigated, the evidence, statements, and the facts will determine if discipline is warranted and the definitions in the Code of Student Conduct will determine what offense code will be used. It is extremely important to read the full definition in the Code of Student Conduct to make sure the incident is accurately reported. If the incident does not meet the SESIR definition, the Discipline Officer will need to determine the appropriate offense code that matches the facts and evidence of the incident. Link to "Does Offense Code for Incident Match SESIR Definition?"	It is very important that the details of the incident be recorded in Skyward. According to General Records Schedule GS7 for Public Schools Pre-K-12, student discipline records for major or minor offenses consist of records created in reviewing an adverse action or statement against a student. The records may include, but is not limited to, a copy of the proposed adverse action with supporting documents, statements of witnesses, reports (including bus drivers' reports on students' misbehavior on school buses), and decisions. This link will take you to the location of this document on our Google Site. Section 1006.09(1)(b), Florida Statutes - Duties of school principal relating to student discipline and school safety - states that each suspension and the reasons for the suspension and the reported in writing within 24 hours to the district school superintendent. This is done by entering the referral in Skyward.	The following Zero Tolerance offenses arv required to be Reported to Law Enforcement. In Skyward, Reported to Law must be marked 'Yes' and a number provided by law entered (FL-DOE link to what can be a number). If an incident occurs on your campus and after your investigation you find that more than one SESIR offense could fit the incident, you can only record one SESIR offense in Skyward. The comment field and/or Related elements would be used to document additional SESIR offenses. If a decision must be made between two incident types, make your decision based on which incident caused the most injury or the highest loss of property or monetary cost. If these are not relevant to the incident, base your decision on whatever describes the situation the best or what is most significant. Link to document on Google Site.	When more than one student is involved in the same incident, each student will receive the same offense number in Skyward. Click this <u>link</u> to see additional explanations involving multiple students.	If a general education student commits any of the Zero Tolerance offenses noted in the Required Law Enforcement section of this document, a 10-day suspension is required. In addition to the 10-day suspension, a recommendation for expulsion must be submitted to the Office of Prevention Programs & Alternative Education. Please review Disciplinary Actions in the Code of Student Conduct for assigning discipline. Please review the Due Process Procedures for ADP/Expulsions at this link.	For any SESIR incident, a specific discipline resultant action code is expected when recording incidents in Skyward. FL-DOE Discipline Resultant Action Code If an 'In-School' or 'Out-of-School' suspension is not assigned to a student, the 'Other SESIR Defined' action code can be used along with one of six specific action codes. Click on this link to see what six specific action codes can be used with 'Other SESIR Defined'.


