## 2021-2022 Mathematics Instructional Materials Call for Reviewers

## Instructional Materials (IM) Adoption Process:

Florida's Benchmarks for Excellent Student Thinking (B.E.S.T.) Standards for Mathematics details the knowledge, skills and resources a student should develop as a result of a quality program in these areas.

## Call for Reviewers:

To evaluate the quality of instructional materials for use in district classrooms, the Florida Department of Education (the department) is seeking reviewers with content expertise and an indepth understanding of the B.E.S.T. Standards. State standards and benchmarks detail what students should know and be able to do as the result of a quality educational program. Instructional materials shall be made available electronically to the state instructional materials reviewers, who shall complete an electronic evaluation of the items to assess whether the materials align to the B.E.S.T. Standards for Mathematics.

The Florida Department of Education received one hundred thirty-six bids for K-12 Mathematics materials. The breakdown by subject areas is included below.

# **State Reviewer Qualifications:**

State instructional materials reviewers will hold one or more of the following credentials in the field of Mathematics:

- 1. A master's degree or higher;
- 2. Educator Certification;
- 3. Substantial experience with evidence of Mathematics content expertise and student achievement; or
- 4. Recognition as a mathematics content expert. Such recognition may include, but is not limited to, awards received or publications related to the field of Mathematics.

## Specifically:

Qualifications for K-5 Mathematics reviewers:

- 5 years of teaching experience
- One of more of the following certifications:
  - Prek-Grade 3
  - Elementary Education (K-6)

Qualifications for 6-8 Mathematics reviewers:

- 5 years of teaching experience
- One of more of the following certifications:
  - Middle Grades Mathematics (5-9)
  - Mathematics 6-12

Qualifications for 9-12 Mathematics reviewers:

- 5 years of teaching experience
- Certification in Mathematics 6-12

#### **Stipend for Reviewers:**

A stipend will be paid to all state instructional materials reviewers. In accordance with section 1006.29(1)(d), Florida Statutes, the department, as of July 1, 2014, may assess and collect fees from publishers participating in the instructional materials approval process. The monies so collected will be used to pay a stipend to state instructional materials reviewers.

Reviewers will receive a stipend of \$330 for each bid evaluated. <u>All stipend checks will be</u> <u>mailed within 30 days upon the completion of the state adoption in its entirety.</u> Evaluating instructional materials for the state adoption requires time and effort; it is an undertaking that is very important and will support our goal for all Florida students to receive a high-quality education that will prepare them to be active citizens, critical thinkers and lifelong learners.

#### **State Instructional Materials Reviewer Registration:**

To register as a reviewer:

Step 1:

- Go to: <u>https://www.flimadoption.org/</u> then click on Open Cycles. You will see all active adoption cycles for Mathematics. Click on the "Call for Expert Reviewers" to review the requirements and apply to be an expert reviewer.
- Review the information on the Call for Experts tab and click on the "Sign in or Create an Account" button located on the right side of that tab to set up your general user account.

- After you have signed up, you will receive a verification email. To verify your email address, please click on the verification link located in the email.
- Once you have verified your user account you will be directed to a log in screen. Sign in to your user account by using the e-mail you provided and the password that you chose.
- Once logged into your user account, you will then click on the "Open Cycles" option again to access your reviewer application.

Step 2:

- Click on the "Call for Expert Reviewers" option and then click on the "Sign up to be an Expert Reviewer" option to fill out your application to be an expert reviewer.
- Complete the reviewer application by answering all required fields. Please be sure to see the example below on how to demonstrate you meet all qualifications.
- Once your application has been submitted, you will receive a notification e-mail confirming receipt of your application. The Instructional Materials staff will review your application once all required reviewer documentation has been received.
- Once you complete your application to become an expert reviewer, you will also need to complete the following: Reviewer Stipend Justification Form, Reviewer Affidavit and the online W-9 form via the State of Florida Vendor site.
  \*\*Please note that your *application is NOT complete and will not be reviewed until*

these forms are completed and received by mail by IM staff.\*\*

## State Affidavit:

All state reviewers must be able to sign an affidavit attesting compliance with section 1006.30, Florida Statutes.

#### 1006.30 Affidavit of state instructional materials reviewers.-

Before transacting any business, each state instructional materials reviewer shall make an affidavit, to be filed with the department, that:

- (1) The reviewer will faithfully discharge the duties imposed upon him or her.
- (2) The reviewer has no interest in any publishing or manufacturing organization that produces or sells instructional materials.
- (3) The reviewer is in no way connected with the distribution of the instructional materials.

- (4) The reviewer does not have any direct or indirect pecuniary interest in the business or profits of any person engaged in manufacturing, publishing, or selling instructional materials designed for use in the public schools.
- (5) The reviewer will not accept any emolument or promise of future reward of any kind from any publisher or manufacturer of instructional materials or his or her agent or anyone interested in, or intending to bias his or her judgment in any way in, the selection of any materials to be adopted.
- (6) The reviewer understands that it is unlawful to discuss matters relating to instructional materials submitted for adoption with any agent of a publisher or manufacturer of instructional materials, either directly or indirectly, except during the period when the publisher or manufacturer is providing a presentation for the reviewer during his or her review of the instructional materials submitted for adoption.

## Next Steps:

- If you are selected, you will be notified of account activation via email within 30 days. All reviewer notifications regarding the instructional materials review process will be sent via email; hence, please be sure to provide an accurate email address.
- Once your affidavit is received, your bid(s) will be assigned and an email will be sent to start your evaluation(s).
- An IM Training link and IM Online Reference Guide will be available on the Review Portal and **must** be reviewed *before* starting your evaluations.
- The entire evaluation process is conducted online, with the evaluation rubric and access to the instructional materials available through the IM Review Portal.
- There is no required travel, and no hardcopy samples will be sent to you.

All training materials will be posted on the review website for future reference.

The IM Review Training Presentation covers the evaluation policies; areas of review; rating scale; and how to access, evaluate and use the online evaluation tool. The Evaluation Quick Reference Guide provides a quick tutorial of the IM Review Portal – how to access the materials for review, and review of the evaluation areas. The B.E.S.T. Standards and Mathematics trainings cover new standards and concepts and how to evaluate these in instructional materials.

### Each bid must be completed within three weeks from the assignment date.
