# B.E.S.T. Writing Anchor Sets Grade 7



The Florida Department of Education is publishing the Benchmarks for Excellent Student Thinking (B.E.S.T.) Writing scoring anchors and annotations in support of its efforts to maintain transparency of the scoring process for Florida's statewide, standardized Writing assessments. These anchors can be used as a resource for Florida educators, schools, and districts regarding the scoring of student responses on the B.E.S.T. Writing assessments.

Each spring, students in grades 4–10 are administered a set of source texts and a writing prompt based on those sources. Students respond to one of two possible modes – expository or argumentative – and must draw on reading and writing skills while integrating information from the source materials in order to develop and draft a typed, cohesive essay response.

Anchor sets are used as a primary reference for expert scorers as they score student responses to prompts and sources provided during the spring B.E.S.T. Writing administration. Essays selected for the anchor demonstrate a range of skill levels within each scorepoint on the B.E.S.T. Writing rubric. A bulleted annotation follows each response to explain the prominent characteristics of the response in each domain – *Purpose and Structure, Development*, and *Language* – described in the rubric. As scorers read student responses, they use the anchor to help determine which scorepoint best fits a response holistically.

As with all assessment content, papers selected for the anchor set are reviewed by multiple committees of Florida educators and include members of the *Just Read, Florida!* office and State Regional Literacy Directors (SRLDs). After these meetings, the state's scoring subcontractor, Data Recognition Corporation (DRC), and the Department's ELA content teams assemble final materials for scorers.

All responses are scored holistically; however, responses at any grade level that do not include source citation cannot earn a score higher than 2 in the *Development* domain.

- A claim is presented (*I think that plastic bottles should be banned because they take a lot to deliver, they are bad for the enviornmente , and they coast way more*).
- There is little discernible organizational structure demonstrated, as ideas are listed and do not progress.
- Transitional words and/or phrases are absent.
- The introduction and conclusion statements are brief, with only a sentence each, and do not contribute to a sense of completeness.
- The response is too brief to demonstrate knowledge of purpose, structure, or task.
- 1 Development Below grade-level performance demonstrated
- Multiple sources are used, but ideas derived from the sources lack development (so thats a lot of gas and work just to deliver them).
- Little knowledge of elaborative techniques is demonstrated, as there are minimal attempts to extend on source ideas.
- A counterclaim is not addressed.
- Evidence is appropriately cited using source numbers, but that alone is not enough to advance the score point.
- The response is too brief to demonstrate knowledge of elaboration and topic.
- 1 Language Below grade-level performance demonstrated
- Vocabulary and word choice are vague and unclear (...wich is a big wast of plastic that is horrible for the environment).
- Sentence structure is simplistic.
- A lack of command of conventions is demonstrated, as there is a density and variety of severe errors in capitalization, punctuation (commas, apostrophes), spelling, and sentence formation.
- The response is too brief to establish or maintain tone and/or voice.

#### 1 – Purpose/Structure – Below grade-level performance demonstrated

- A claim is provided (*no plastis water bottles shouldnt be ban*) but minimally sustained.
- Little awareness of organizational structure is demonstrated.
- There are a few transitional words, but they are ineffective (So; In the end).
- The introduction and conclusion are minimal and add little to the response.
- The response is too brief to demonstrate knowledge of purpose, structure, or task.

#### 1 – Development – Below grade-level performance demonstrated

- A lack of development is demonstrated as only one idea about unsafe tap water is presented and minimally elaborated.
- Elaboration demonstrates little knowledge of elaborative techniques with minimal extension of source ideas (*Some places in the world dont have clean , safe tap water so the safest way is drinking water bottles . So its would be hard if water bottles were ban and people would have to drink the unsafe tap water*).
- A counterclaim is provided but somewhat confusing (*Some people may say drink tap water but live in a county were tap water isnt safe to drink*).
- A single source is used and appropriately cited, but that alone is not enough to advance the score point.
- The response is too brief to demonstrate knowledge of the topic.
- 1 Language Below grade-level performance demonstrated
- Word choice is unclear and confusing (Now im going to tell you why; its would be hard if water bottles were ban).
- Sentence structure is simplistic and confusing (*In the end water bottles shouldnt be ban*. *Because it wouldnt be fair for someone to have to drink unsafe tap water*. *So not water bottles shouldnt be ban*).
- A lack of command of conventions is demonstrated, as there is a density and a variety of errors in capitalization, punctuation (apostrophes), spelling, and sentence formation, at times obscuring meaning.
- The response is too brief to establish or maintain appropriate tone and/or voice.
- Brevity with errors demonstrates a lack of command of language skills.

- A claim is provided (*I think plastic water bottles should be banned because if people are not trying to take care of are country then we shouldnt have something that can put animals and living things in danger*) but is confusing and insufficiently sustained throughout.
- Little awareness of organizational structure is demonstrated as there is a list of ideas presented that does little to advance the argument.
- Transitional words and/or phrases are relatively few and do little to connect ideas (*that explains; if people dont want...then they should; this is probaly some of the resoans; this is my opinion*).
- A brief introduction and conclusion are present, providing a minimal framework for the response.
- 1 Development Below grade-level performance demonstrated
- Minimal development of the topic is demonstrated.
- Elaboration attempts to extend ideas but provides minimal support and is somewhat confusing (and all these water bottles that are laying around are releasing toxic chemicals that are going into the air we humans breath this is probaly some of the resoans why we are having majure virusis and stuff).
- Evidence from sources is present but minimally integrated.
- Appropriate citations are present in the form of paragraph numbers, but this alone does not advance the score point.
- No counterclaim is acknowledged.
- 1 Language Below grade-level performance demonstrated
- Word choice is confusing and unclear (*if people are not trying to take care of are country; then they should reycicle there trash; and more; wasting money on things that are gonna harm animials*).
- Sentence structure is confusing (we are having majure virusis and stuff all that stuff will be prevanted if we followed the rules) and simplistic (this is my opinion about if we should banned the plastic water bottle).
- A lack of command of standard English conventions is demonstrated with a density and variety of errors, and at times the meaning of words is obscured (*that explains every thing if people dont want to hurt animals then they should reycicle there trash they usaully harm animals like fish seaturtles dolphins and more; nuture would be so much better and are world will be better*).
- Tone and/or voice are conversational and do not elevate the response beyond a 1.

Write an argumentative essay about whether or not plastic water bottles should be banned.

I think that plastic water bottles should be banned because when people use plastic water bottles people don't recylce they just litter. They don't take care of the world because they dont recycle bottled water. It also causes problems to the animals.

Some of the littered water bottles go to the ocean and some sea animals can easily die just by eating them. - The claim (*I think that plastic water bottles should be banned because when people use plastic water bottles people don't recylce they just litter*) is insufficiently sustained within the task.
- Organizational structure is inconsistent, and there is little progression in the two body paragraphs, which disrupts the advancement of ideas.
- A few transitional words attempt to connect ideas (*It also; just by; They can also be; but others don't think the same way; I still think*).
- An ineffective introduction and simple conclusion are included.
- 2 Development Approaching the range of grade-level performance
- Development demonstrates a partial understanding of the topic.
- Elaboration attempts to develop the argument but provides some loosely related information (Using plastic water bottles can make our environment not clean or safe. We can die just for a bottled water).
- Evidence is partially integrated and related to the topic but somewhat disconnected from the argument.
- A counterclaim is acknowledged (*Some people think it should be banned but others don't think the same way*).
- Multiple sources are used, but reference to the text (*In the text it says*) is not an appropriate citation.

#### 2 – Language – Approaching the range of grade-level performance

- Vocabulary and word choice are unclear, demonstrating partial command of expression of ideas (*THey think its alot faster to drink just by using water bottles*).
- Sentence structure is partially controlled and somewhat simplistic, demonstrating a lack of gradeappropriate language facility.
- Inconsistent use of correct grammar (*its* for it's; *their* for they're), punctuation (*dont*; missing commas), capitalization (*THey*), and spelling (*recylce; becasue; thirty; alot*) demonstrates a partial command of standard English conventions.
- Tone and/or voice are informal for an academic argumentative essay.

Write an argumentative essay about whether or not plastic water bottles should be banned.

- A claim is provided (*Plastic water bottles should be banned*) and somewhat sustained.
- Transitions attempt to connect ideas, but they lack purpose and variety (*Some of the problems; Another problem*).
- An introduction and conclusion are present but simplistic.
- The organizational structure is repetitive, somewhat disrupting the advancement of ideas. Each body paragraph presents an idea, a paraphrase, and a citation but is limited in sustaining the idea.

- A partial and incomplete understanding of the topic is demonstrated.
- Elaboration attempts to develop the argument using source ideas with little extension (*Thats a lot of money just to spen just for plastic water bottles. That's a thousand times more than what we have to play for faucet water at home; People use these plastic bottles and throw them on the ground. These water bottles that are thrown on the groud find their way to the ocean*).
- Multiple sources are used, but they are partially integrated and somewhat ineffective.
- A counterclaim is not acknowledged.
- An appropriate citation is missing (*In the text it says*).

#### 2 – Language – Approaching the range of grade-level performance

- Vocabulary and word choice are basic, demonstrating partial command of expression (*Some of the problems we face with waterbottles is pollution; other things; big amount; many more reasons*).
- Sentence structure is simplistic and lacks grade-appropriate language facility (*Another problem we have is how much money were spending on it*).
- Inconsistent use of correct grammar (*were* for we're; *what we have to play; Its* for It's; *more safer*), punctuation (missing commas; *Thats*), and spelling (*procces; spen; mayjor*) is demonstrated, though not to a high degree of density nor severity overall.
- Tone and/or voice are inconsistent and conversational.

Bottled water. The common luxury of the modern day, while being fairly conveniant, these bottles bring many cons to the table. - A claim is provided (*I personally believe that we should ban them all together for a variety of reasons*), but it is unclear and insufficiently sustained.
- The organizational structure is limited and repetitive, disrupting the advancement of ideas. The second body paragraph mentions bottled water being federally regulated several times, partially advancing the argument.
- Transitions are present, and they are attempting to connect ideas within and among paragraphs, but they lack variety (*To start off; To sum it up; Secondly; In summary; In conclusion*).
- The introduction and conclusion are present yet simplistic. The introduction provides the claim and two reasons why water bottles should be banned, and the conclusion provides a brief restatement of those ideas.
- 2 Development Approaching the range of grade-level performance
- A partial understanding of the topic is demonstrated.
- Elaboration attempts to develop the argument with simplistic extensions on source evidence (*This piece of evidence further proves my point, by relating my point to something more imaginable. Have you ever went to the beach and saw many pieces of plastic and garbage? Now imagine that 1,000,000 times more and thats still smaller than the amount of plastic in the ocean*).
- Multiple sources are used, but they are partially integrated and somewhat ineffective when supporting the argument.
- Evidence is appropriately cited using paragraph numbers, but citation alone does not elevate the development.
- A slight acknowledgement to a counterclaim is provided in the introduction (*while being fairly conveniant*).

- Vocabulary and word choice are basic, demonstrating a partial command of expression of ideas (*This citation shows that bottled water in the United States is not even needed*).
- Sentence structure is partially controlled, lacking grade-appropriate language facility (*These plastic containers can greatly pollute the ocean, and tap water is federally regulated in the U.S.*).
- Although there are not a lot of grammar or convention errors, the essay is simplistic and does not reflect grade-appropriate language skills.
- Tone and/or voice are conversational.

Write an argumentative essay about whether or not plastic water bottles should be banned.e

I think plastic water bottles should be banned. First, of all palstic water bottles add up to an excessive waste. Second, 91% of all the plastic water bottles that are consumed are not being recycled. Lastly, why do we do we even use plastic bottles if it's a health risk for us?

These are some astonshing facts. If you are wondering how long it might take for a plastic bottle to decompose well... it's only around like 400 years for it to naturally decompose (paragraph 30, Source 3).

Lastly, us humans who live in a place with safe drinking tap water use to many plastic bottled waters because we find it as a indulgences or convinent. There is no point in buying plastic water bottles if it is safe to drink from the tap. Not only do plastic water bottles contribute to excessive waste but they also harm you with chemicals. Not only do plastic water bottles contribute to excessive waste but they also harm you with chemicals).
- Multiple sources are used, but they are partially integrated.
- No counterclaim is acknowledged.
- Evidence is appropriately cited, using multiple sources (*paragraph 32 from Plastic in the Ocean; paragraph 7, Source 1*), but that alone does not elevate the score.

- Word choice is simplistic, demonstrating partial command of expression of ideas (*Not only do plastic water bottles contribute to excessive waste but they also harm you with chemicals*).
- Sentence structure is partially controlled and somewhat simplistic.
- The response is grammatically accurate overall with relatively few errors but does not demonstrate grade-appropriate language facility.
- Tone and/or voice are inconsistent in the context provided.

Write an argumentative essay about whether or not plastic water bottles should be banned.

Have you ever thought of water bottles being bad? Water bottles can cause a ton of harm to the environment and people are trying to ban them, so should we get rid of them fully? I believe we should, let me tell you how much waste it causes, the health of water bottles, and why its important to get them banned.

How much waste does water bottles cause? Water bottles make so much waste that in the ocean there is going to be so much plastic in just a few years. - The organizational structure is somewhat sustained but is simplistic and limited in connecting ideas.
- Rhetorical questions are used as topic sentences to introduce ideas for the body paragraphs, and internal transitions attempt to connect ideas within paragraphs (*This explains; What this means; This says*).

Some would argue that humans will not go extinct because humans would survive on plants. However based on "Source 1: Why Tap water Is Better Than Bottled Water" "...it takes up to thee liters of water to produce one liter of bottled water". Plants need water to survive but since water bottles are not banned the water bottles will take up all the water. The plants would die. The animals would already be dead. Next it's humans. After that, there is nothing left. Therefore, plastic water bottles should be banned because it would end life on planet Earth.

However, it's very clear that what most people would like to think they'd choose in the real world doesn't match up with reality. Thus, the plastic water bottle! It's nothing special, just a bottled water that you can pop a few quarters into the vending machine for or buy a value pack of at your local grocery store. It's the pinicle of choosing convenience over what's best in the long haul. In fact, due to factors such as extreme prices, a lack of recycling, and carbon dioxide emissions many people have been rightfully calling for the ban of bottled water. Sounds ridiculous? Well, whats worse than ridiculous is downright dangerous.

To get a better idea of what that means, Nace goes on to explain that by just 2050 the ocean is predicted to "contain more plastic...than fish." And if you surround a hungry marine animal with enough of anything it's going to find a way into their stomach whether by accident or on purpose. Furthermore, we as the human race and thus apex predators have to eat these fish that are consuming plastic waste larger than themselves. If we do not impose plastic bottle bans and *fast,* we will eventually become a target of our own mistakes. Don't want to be eating plastic garbage less than 30 years from now? Then make the right decision and fight for a bottled water ban.

Whilst plastic bottles may be costing us a fortune monetarily and physically, the impact surely stops there, right? Well, you'd be right to think that if it weren't a little something called carbon dioxide emissions and global warming. Based on research done by Sierra Club, a non-profit organization focused on saving our environment, trasnporting these plastic bottles from factories to grocery stores takes up a lot of fossil fuels. And as most people would've known from news articles and reports, burning fossil fuels gives off lots more greenhouse gases than our atmosphere can afford to take in.
