Instructional Materials Adoption Cycle

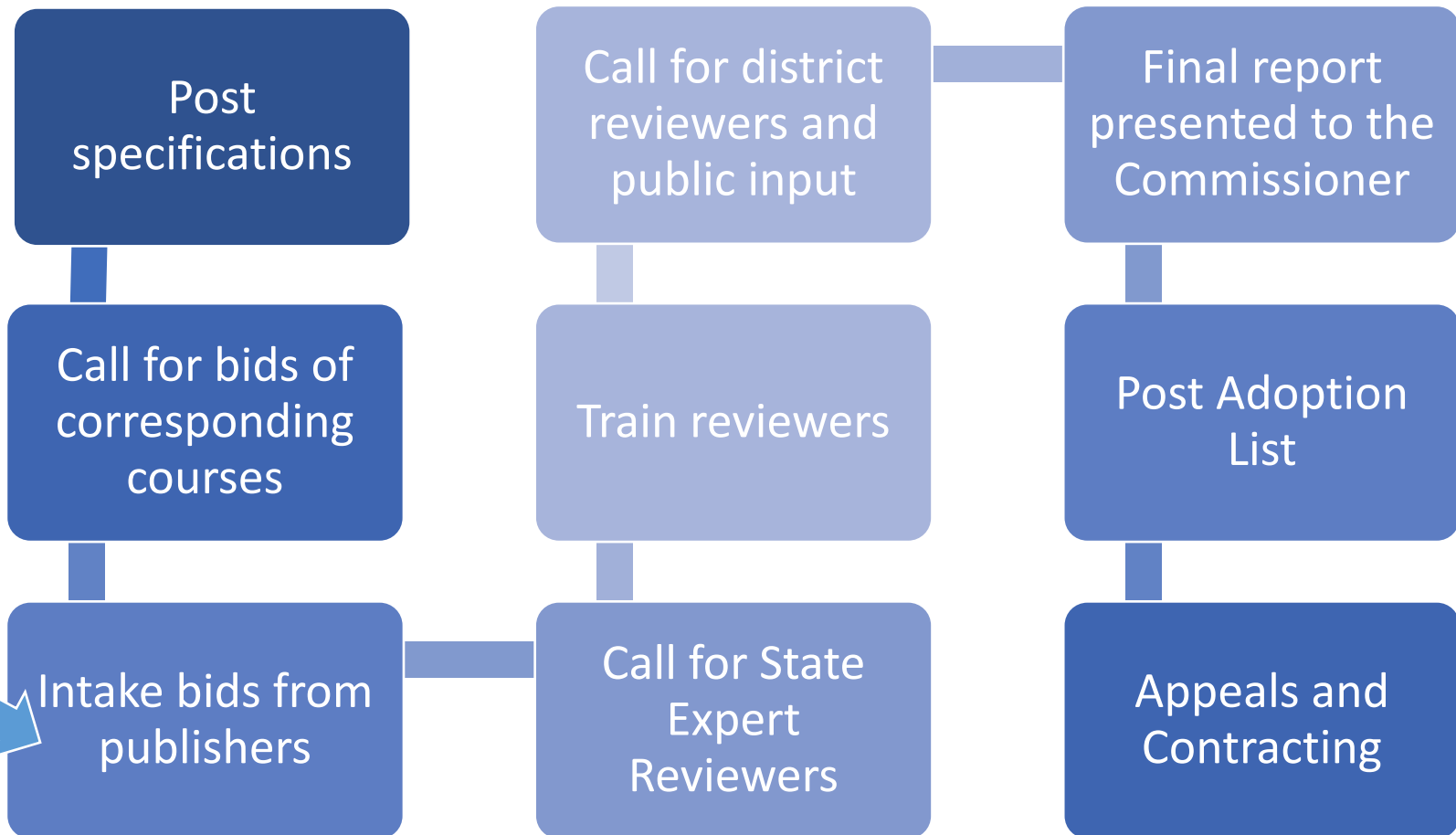
Current Adoptions

- 2023-2024 K-12 Science
- Publishers: 14
- Bids submitted: 143
- Courses:
 - K-5: 6 series = 36 bids
 - 6-8: 60 bids
 - 9-12: 47 bids

Current Adoptions, continued

- 2024-2025 K-12 English Language Arts (ELA), 9-12 Personal Financial Literacy and Money Management, K-4 Mathematics Intervention Materials and K-3 ELA Intervention Materials.
- The intent to bid closed on May 10, 2024:
 - 9-12 Personal Financial Literacy and Money Managements – 18 intent to bids.
 - K-12 ELA – 118 intent to bids.
 - K-3 ELA Intervention Materials – 150 intent to bids.
 - K-4 Mathematics Intervention Materials – 65 intent to bids.

2024 Legislative Session

Senate Bill 7004 (2024)

- Amended section (s.) 1006.33, Florida Statutes (F.S.), to state:
 - Beginning with the 2025-2026 instructional materials adoption cycle, the department shall publish an instructional materials adoption timeline which must include, but is not limited to, publishing bid specifications, advertising in the Florida Administrative Register, and deadlines for the submission of bids.

Senate Bill 7004 (2024), continued

- Amended s. 1006.33, F.S., to state:
 - ...The adoption cycle must include at least 6 months between the release of the bid specifications and the deadline for the submission of bids. The adoption cycle must specify that the Commissioner of Education shall publish an initial list of state-adopted instructional materials no later than December 1, 2025. This subparagraph shall expire July 1, 2026.

Senate Bill 7004 (2024), continued

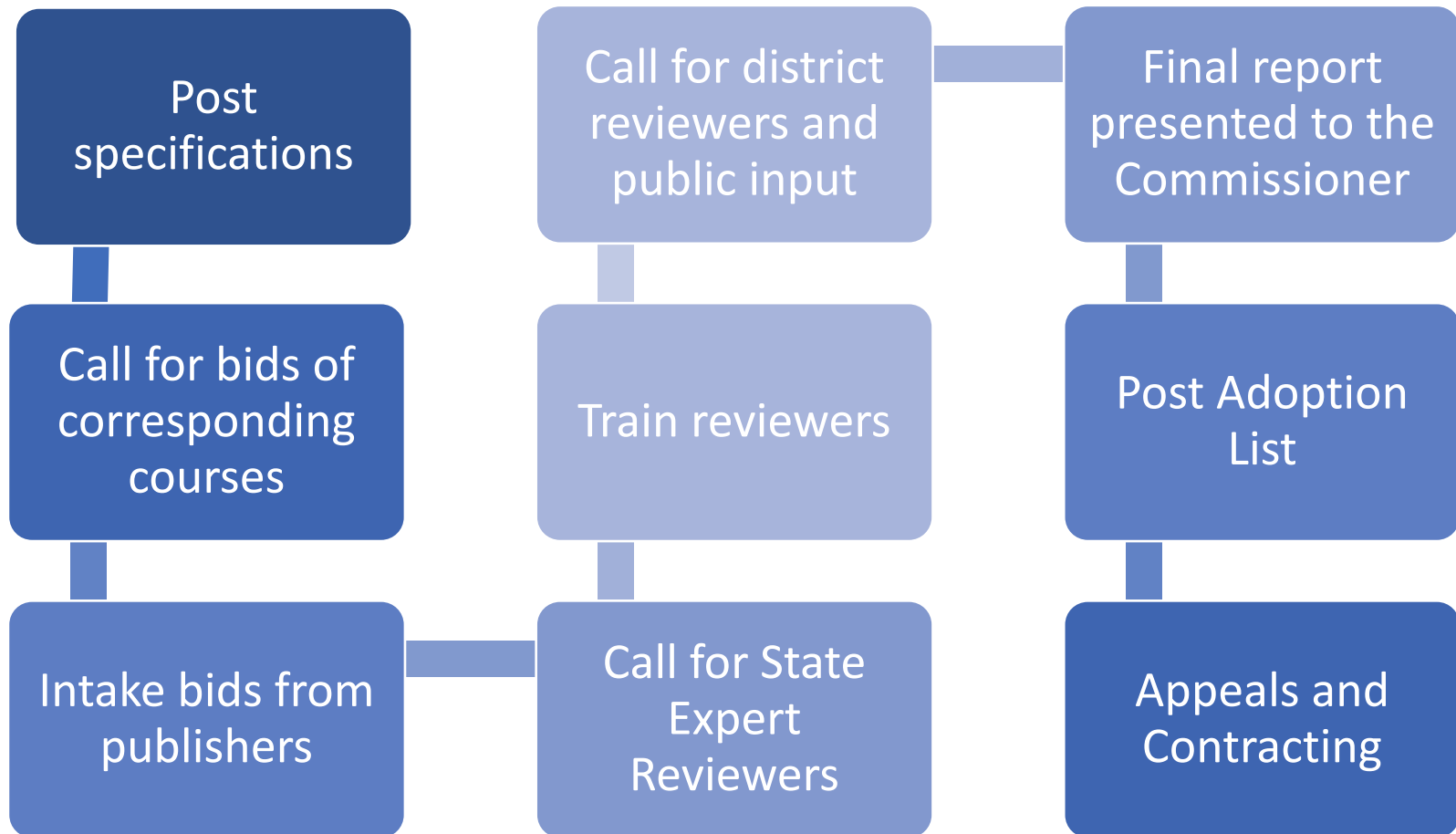
- S. 1006.33, F.S., was also amended to state:
 - Beginning with the 2026-2027 instructional materials adoption cycle and thereafter, the department shall publish an instructional materials adoption timeline which must include, but is not limited to, publishing bid specifications, advertising in the Florida Administrative Register, and deadlines for the submission of bids. The adoption cycle must include at least 6 months between the release of the bid specifications and the deadline for the submission of bids, and publication of an initial list of state-adopted instructional materials no later than July 31 in the year preceding the adoption.



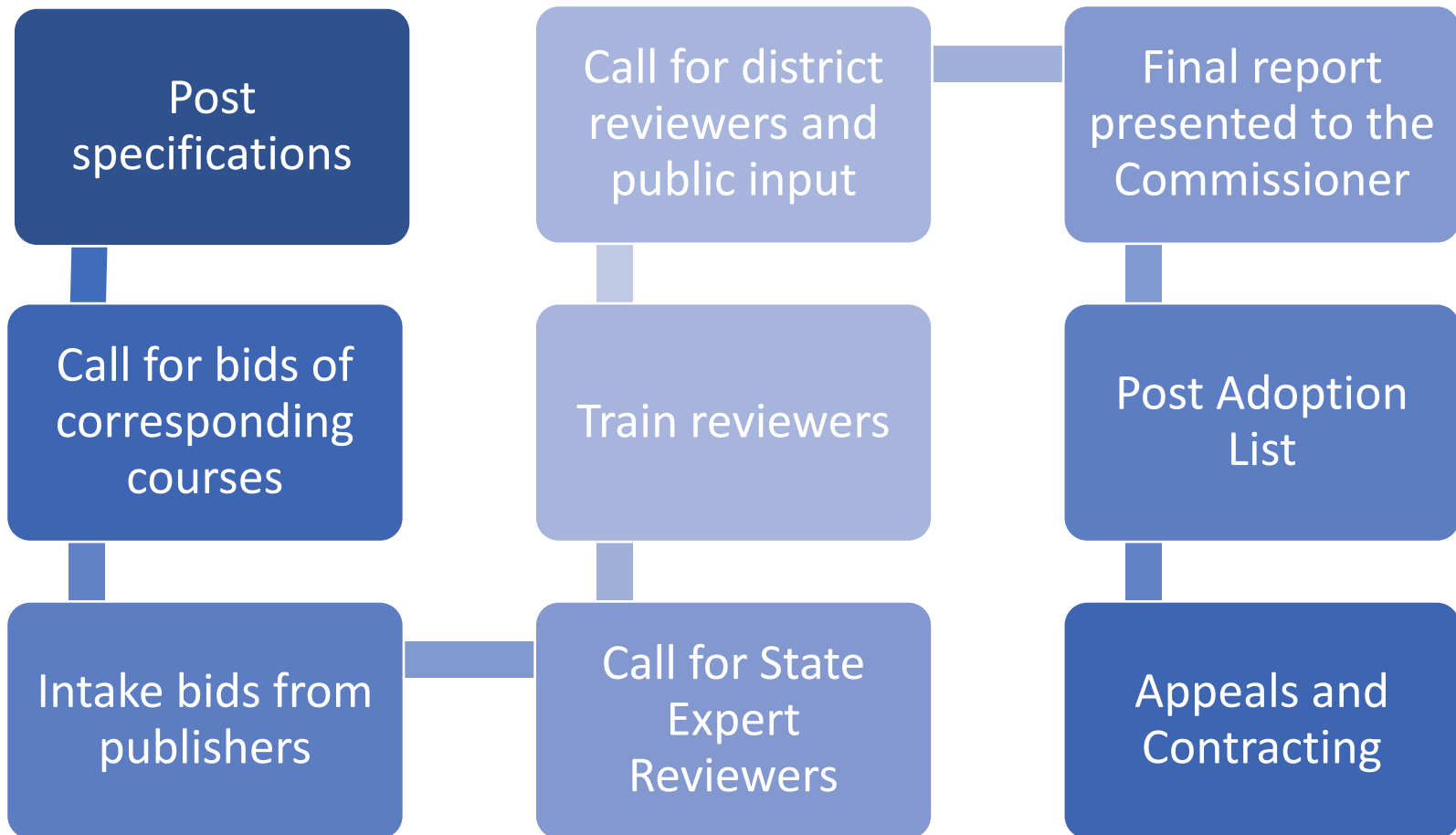

Important Dates to Remember

- 2024-2025 adoption will run on the “old” timeline. The anticipated date for the adoption lists to post is forthcoming.
- 2025-2026 adoption will run on the “transition” timeline. The adoption lists will post by December 1, 2025.
- 2026-2027 and thereafter adoption will run on the “new” timeline. The adoption lists will post by July 31, 2026.

2025-2026	Career and Technical Education, World Languages, Art, Music, Dance and Health, K-12 ; Additional English Language Arts, 6-12	Nov. 2024	April 2025-2026	2026-2031
2026-2027	Mathematics and Computer Science, K-12	Nov. 2025	April 2026-2027	2027-2032
2027-2028	Social Studies, K-12	Nov. 2026	April 2027-2028	2028-2033
