## NOVEMBER QUARTERLY REPORT 2006


The Corporate Tax Credit (CTC) Scholarship Program was established to encourage private, voluntary contributions from corporate donors to non-profit scholarship funding organizations that award scholarships to children from low-income families. A corporation can receive a dollar for dollar tax credit up to 75% of its state income tax liability, and the state may award a maximum of \$88 million in credits each year. This program expands educational opportunities and school choice for children of families that have limited financial resources.



## **CTC Student Enrollment by Gender**






#### **CTC Student Racial/Ethnic Enrollment**



# CTC Student Enrollment by Scholarship Funding Organization (SFO)




