General Appropriations Act

- Senate Bill 2500
- Pending presentation to the Governor.
- Critical Workforce Programs
 - Pathways to Career Opportunity Act (new and carry forward funds to continue 20-21 new grants)
 - Open Door Grant Program
 - Money Back Program



2021 Session Highlights

- <u>House Bill 1507</u> Workforce Related Programs and Services
- Creates the Office of Reimagining Education and Career Help (REACH) in the Executive Office of the Governor to provide coordination and alignment in Florida's workforce development system.
- Requires the Office to create a "no-wrong-door" entry strategy whereby Floridians may access services from any workforce partner.
- Requires the CareerSource state board to appoint a Credentials Review Committee to identify degree and nondegree credentials of value, and develop a Master Credentials List for performance funding, including CAPE Industry Certification.
- Creates the Open Door Workforce Grant Program to provide grants to school districts and Florida College System (FCS) institutions to cover up to two-thirds of the cost of short-term, high-demand programs.
- Creates the Money-Back Guarantee Program, requiring each school district and FCS institution to refund the cost of tuition to students who are not able to find a job within 6 months of completing select programs.



2021 Session Highlights

- <u>House Bill 735</u> Preemption of Local Occupational Licenses
- Preempts the licensing of occupations to the state and prohibits local governments from imposing or modifying license requirements
- <u>Senate Bill 52</u> Postsecondary Education
- Renames the collegiate high school program the early college program and modifies requirements.
- Creates the Dual Enrollment Scholarship Program to reimburse tuition to all participating institutions for private and home school students all year plus public school students in the summer.
- <u>Senate Bill 366</u> Educational Opportunities Leading to Employment
- Provides support for students in work-based learning programs, increases access to dual enrollment by providing for the adoption of alternate methods (like those used during the pandemic) to qualify students, and creates three math course sequences ("pathways") for college/university students based on their college major and career choice.

2021-2022 Curriculum Frameworks

- 2021-2022 Draft Adult Curriculum Frameworks are currently posted on the AE Web Page
- Scheduled for review and approval during the June 10th, 2021 State Board of Education Meeting
- No major content changes, however there are new CIP codes assigned to the ABE, AHS, ESOL and GED program numbers as part of the federal ten year update process
- The Co-Enrolled List will be forthcoming-no major additions or deletions



B.E.S.T. Standards Alignment

- Adult Education Curriculum Frameworks are currently being reviewed by national consultants in conjunction with IPDAE to analyze alignment with Florida's K-12 B.E.S.T. Standards
- Limited to NRS reportable programs
- As of research to date, approximately 50% are strongly or moderately aligned
- Work will be completed by June 30th and advisory groups will be established to review recommendations, begin implementation and develop professional development activities

Status of Public GED Testing Centers

- February 1, 2021 April 30
 - 8,702 test takers took 18,373 tests
 - Approximately 34% of the tests were taken using OnVUE
 - In-person testing was available in 56 of the 59 counties in the state that operate public GED testing centers

GED® Testing – Vouchers

- GED[®] Testing/Pearson VUE vouchers are good for one year, so make sure to plan accordingly to only purchase what you will actually use in that time period. Here are a few tips to keep in mind:
 - Prior to ordering vouchers, plan out the number you will actually be able to use before they expire.
 - Monitor your inventory of current vouchers.
 - Have a plan in place for using your vouchers based on the expiration dates.
 - If you know you will be unable to use all of your vouchers by the expiration dates, contact us 4-6 weeks prior to expiration so that we can try to get them extended and/or reissued. (This is a last resort – plan accordingly to use your vouchers by the expiration date.)
 - It can take several weeks to extend/reissue vouchers

Grants Administration and Compliance

2020-2021 Adult Education Grant Year

- FDOE Internal Process No Cost Extension
 - August 31, 2021
- All Adult Education Projects
- Agencies must spend funds only on allowable activities
- If an agency elects to adjust their approved budget line items, then the agency **must** submit a Budget Amendment (through OGM Share File System)
