Prekindergarten Child Outcome Summary (COS)

Prekindergarten COS Train-the-Trainer sessions are being offered by the Technical Assistance & Training System (TATS) via a two-day Zoom training series. District administrators can select from two options for participating staff, **May 19 and 21** or **June 8 and 9, 2021**; both options are from 9:00 to 11:30 a.m. EDT. District administrators should include those individuals identified as being a part of the initial COS process or those who provide prekindergarten professional development, as they will be the ones conducting entry starting **July 1, 2021**, and will play a role in training the rest of district personnel at a later date. All trainings will be done by TATS to support the transition to the COS, which will begin on **July 1, 2021**. The offered training is required by all districts in support of Preschool Child Outcomes - Federal Part B Indicator 7. Rookie ESE Administrator of the year:

This individual should be an administrator of special education programs that has worked in this position for 3 years or less. This person should demonstrate vision and leadership skills that have supported children with disabilities and their families. The winner of this award will receive a plaque, paid registration for the 2022 Florida CASE Summer Leadership Institute as well as the recognition of their peers at the Florida CASE Summer Virtual Institute. Individuals nominated for this award do not need to be a member of CASE but must be a member of CEC.

Outstanding ESE Administrator of the year:

This individual should be an administrator of special education programs that has worked in this position for 5 to 20 years. A person who demonstrates consistent, outstanding vision and leadership for children with disabilities and their families and be recognized for the contributions they have made not only to their district but to their community and state. Individuals nominated for this award must be a current member of National CASE. Winner of this award will also receive a plaque, paid registration for the 2022 Florida CASE Summer Leadership Institute, a beautiful gift basket and recognition at the CASE Summer Institute. This individual may also be submitted as a nominee for the National CASE award.

Life Time Achievement Award:

This individual should be an administrator of special education programs for 20 years or more and has demonstrated consistent and outstanding vision and leadership for children with disabilities and their families and be recognized for the contributions they have made not only to their district but to their community and state. The nominee for this award must be a current and longtime member of CASE. Winner of this award will receive a plaque, paid registration to the 2022 Florida CASE Summer Leadership Institute, National CASE or National CEC Conference and recognition at the Florida CASE Summer Virtual Institute.
