### Partnership for Effective Programs for Students with Autism (PEPSA)

PEPSA is an initiative to support educators and schools' professional development and training programs. Our mission is to enhance programs for students with autism spectrum disorder (ASD), through a variety of regional training events and a partnership program with the statewide Centers for Autism and Related Disabilities (CARD). We are currently accepting applications for our fiscal year 2023-24 cohort. The PEPSA/CARD Partnership Program is an initiative that supports educators' professional development to enhance school programs for students with ASD in Florida. Every year, PEPSA and CARD join to select a cohort of educators and provide them with training and technical assistance to develop and implement innovative and effective practices within educational programs for students with ASD. Participants are matched to a CARD site and consultant professional who will mentor the educator or school staff. The CARD partner will provide support, resources, technical assistance and training that is specific to the needs identified by the educator or school.
