<p>A code which indicates the program in which a kindergarten student participated in the year prior to kindergarten entry. <b>Definition/Domain (Continued)</b>	
<u>CODE</u>	<u>DEFINITION</u>
<b>P</b>	<b>Non-district Prekindergarten Program</b> - A preschool not operated by or contracted by a school district.
<b>D</b>	<b>Prekindergarten Program for Children with Disabilities</b> - A federally and state funded program within the Florida Education Finance Program (FEFP) for three and four year olds with disabilities.
<b>I</b>	<b>Prekindergarten Early Intervention</b> - A state funded program serving three and four year olds who meet specific eligibility requirements.
<b>S</b>	<b>Subsidized Child Care</b> - A federal and/or state funded program serving children birth to age 12 through which an eligible family receives a government subsidy to pay the total or partial costs of child care. The location of the care does not necessarily determine subsidized child care status. This code is to be used for recording prekindergarten participation in a program provided by a district through contracted services.
<b>O</b>	<b>Prekindergarten, Other</b> - A preschool program operated by a school district (excluding those identified above).
