<b>Definition/Domain</b>													
<p>A code which indicates the status of a student regarding eligibility for Title I Supplemental Education Services because the student attends a School In Need of Improvement (SINI) pursuant to Title I, Part A, Section 1116, Elementary and Secondary Education Act (ESEA) as amended by No Child Left Behind (NCLB).
