<b>Code</b>	<b>Definition/Example</b>
E	Yes, this course is used to provide reading intervention for this student. This student is also receiving extended time in reading intervention before school, after school, or at another time during the school day. This code applies to students in grade levels 6-12 only.
F	Flexibility – This course is used to provide reading intervention to students who have met the graduation requirement in reading with a score of Level 2 on FCAT Reading (or a concordant score) as noted in SBER 6A-6.054(3)(e). Having a student assigned to the class under this “flexibility” provision does not require the teacher of the course to be reading endorsed, reading certified or to have completed Content Area Reading Professional Development, but the teacher must be knowledgeable in providing reading strategies. This code applies to students in grade levels 11 and 12 only.
N	No, this course is not used to provide reading intervention for this student.
Y	Yes, this course is used to provide reading intervention for this student. For grades 6-12, this student is not also receiving extended time in reading intervention before school, after school, or at another time during the school day.
Z	Not applicable. The student is not in grades KG-12.

Note: Report code Z for all students in Survey Periods 1 and 4.
