A career-themed course is a course or a course in a series of courses that leads to an industry certification on the Industry Certification Funding List. They are designed to have an industry specific curriculum aligned to priority workforce needs established by regional workforce boards or the Florida Department of Economic Opportunity. CAPE Participants are students who were enrolled in either a registered academy or career-themed course.
