### Purpose and Approach

- Every Student Succeeds Act (ESSA):
  - Replaced No Child Left Behind (NCLB)
  - Eliminated the reporting of highly qualified teacher status
- Prior Rule Development
- Draft Rule Language
  - Reorganization
  - Definitions



- Proposed Rule Revisions include:
  - Definitions
    - Primary Instructor
    - In-field
    - Out-of-field
  - In-field Conditions



### Codifying In-field Designations

#### Per 1012.42, F.S.

Educator holds a Florida educator's certificate in another subject and

- Minor Field of Study
  - Completed minor field of study in the subject of the instructional assignment (minimum 15 semester hours)
  - Verified by educator's official transcript
- Subject Matter Expertise
  - Demonstrates subject matter expertise through:
    - passage of a standardized examination or
    - Established by school board policy
      - a comparable method for attainment of essential competencies in the subject area to be taught



### Restoring HOUSSE as In-field

Educator holds a Florida educator's certificate in another subject and

- HOUSSE Plan
  - Used to establish highly qualified teacher in core courses status under NCLB
  - Completed beginning with 2006-2007 school year (Florida or out-of-state) OR
  - Used for a world language for which Florida:
    - does not have a state- developed or approved examination or
    - prior to the approval of an exam by the State Board of Education



### Codifying In-field Designations

- Voluntary Prekindergarten Credentialed Instructor per 1002.55(3)(c), 1002.55(4) and 1002.63(5), F.S.
  - Holds at least one of the following credentials:
    - Child development associate credential issued by the National Credentialing Program of the Council of Professional Recognition
    - Comparable credential approved by the Department of Children and Family Services
  - Completes training courses in emergent literacy and student performance standards
- Adjunct Instructor per 1012.57, F.S.
  - Qualifies based on a district certificate, by
  - Demonstrating subject area mastery by passing Florida approved subject area exam



- Proposed Rule Revisions: In-field Primary Instructor
- Conditions Requiring Valid State Certificate

In-field Designations	Reporting Code
a. Hold a valid FL certificate/license per Course Code Directory	I *
b. Hold a valid FL certificate plus minor in field (minimum of 15 semester hours)	Μ
c. Hold a valid FL certificate plus passing SAE scores or other school board method to demonstrate competencies in field	S
d. Hold a valid FL certificate plus HOUSSE plan in field that meets certain criteria	Н



- Proposed Revisions: In-field Primary Instructor
  - Additional In-field Conditions

In-field Designations	Reporting Code
e. Hold district certificate for teaching nondegreed career and technical courses	I *
f. Hold Voluntary Prekindergarten (VPK) credentials	V
g. Hold district certificate as a part-time adjunct teacher	A
h. Hold neither a FL or district certificate, but employed as expert in field	Ν

\* May propose new reporting codes



Questions relating to the qualifications of specialized instructional personnel should be directed to the corresponding office.



### Existing Rule 6A-1.0503, F.A.C.

- Out-of-field
- First year OOF with approval of school board
  - Subsequent years OOF plus earned credit
    - i. OOF subject other than ESOL- 6 semester hours or equivalent annually
    - ii. OOF in ESOL only- 3 semester hours within first 2 years then 3 semester hours annually
    - iii. OOF in ESOL and other subject
  - Waivers of college credit

- March 21- State Board of Education meeting
- Changes effective for the 2018-2019 school year
