 House Bill 189: STEM Teacher Certification



Defense Language Proficiency Test (DLPT)/Defense Language Institute (DLI)

- 6A-4.002, F.A.C., General Provisions
- Satisfies specialization requirements and subject mastery for world language certification
- DLPT: Requires passing scores of 2 or higher on subtests in Reading & Listening
- DLI: Requires official documentation of Basic program completion

Professional Certificates

- 6A-4.004, F.A.C., Florida Educator's Certificates
- Proposed revisions:
 - Revise specificity of requirements for earning a professional certificate
 - Include reference to provisions for renewal and extensions
 - Remove reference to verification of subject matter competencies



STEM Teacher Certification

- 6A-4.004, F.A.C., (cont'd)
- Add alternative requirements for certification in a science, technology, engineering, or mathematics (STEM) grades 6-12 area:
 - Hold a master's degree or higher in a STEM area
 - Earn passing scores on educator certification exams
 - Teach a high school course
 - Achieve a highly effective rating based on student performance on a standardized state or national exam as outlined in a FLDOE approved district evaluation plan
