## Validation Error Codes

The following validation codes are to be used with the <u>Adult Validation Error Report</u>. Validations differ from edit errors as edits check individual records in a single format for required data, and validations check data across formats. For example, a standard Validation check makes sure that every submitted Adult Demographic record has at least one matching (same reporting period) Adult Course record. Please see the error codes listed below for an explanation of what type of validation error was found.
