# DROPOUT PREVENTION AND ACADEMIC INTERVENTION PROGRAMS

# Annual Report • 2023-24



### Overview

The Bureau of School Improvement provides technical assistance, strategies and resources for dropout prevention (DOP) programs and academic interventions programs to assist students, schools, districts, parents and community organizations throughout Florida.

DOP programs provide identified student populations with supplemental support systems to help achieve success. These programs create a multi-layer system of support for students and families facing academic struggles and school disengagement. The Florida Department of Education (FDOE) provides supports to professionals representing exceptional student education, juvenile justice education, dropout prevention, federal programs for at-risk student populations, attendance and truancy, social work, volunteer programs, higher education, faith-based and community-based organizations and family engagement.

#### Purpose

This annual report provides information on dropout prevention and academic intervention programs, including related data on graduation rate, dropout rate, attendance rate and retention/promotion rate, pursuant to section (s.) 1003.53, Florida Statutes (F.S.).

#### **Dropout Prevention Programs**

Pursuant to s. 1003.53(1)(a), F.S., educational programs for dropout prevention and academic intervention shall include curricula, character development and law education and related services that support the program goals and lead to improved performance in the areas of academic achievement, attendance and discipline. Eligible students for DOP programs are students in grades 1-12 who are identified as academically unsuccessful, students with a pattern of excessive absenteeism or habitual truancy, students with a history of disruptive behavior or students identified by a school's early warning system (pursuant to s. 1001.42(18)(b), F.S.).

#### **Dropout Prevention Program Enrollment**

In the 2023-24 school year, 28,947 students participated in one or more DOP programs for 45 days or more of the actual length of the program rather than the prescribed length of the program. The total number of participating students is unduplicated.

Exhibit 1 displays the number of K-12 students enrolled in the various DOP programs. The exhibit represents students who participated 45 days or more of the actual length of program in one or more DOP programs during the 2023-24 school year. The numbers are duplicated, as some students participated in more than one program within the school year.

Exhibit 5 displays the percentage of students participating in DOP programs who also receive additional services. Students participating in DOP programs may also receive services from migrant education programs, English language learner (ELL) education services and exceptional student education services for students with disabilities (SWD).





## **Measuring Student Performance Outcomes**

The following information includes outcome data only for students who participated in a DOP program in 2023-24 for 45 days or more of the actual length of program. Throughout the report, data will be provided on the following outcomes:

- Graduation The number of students in grade 12 who graduated with a high school diploma divided by the total number of students in grade 12.
- Dropout The number of students in grades 9-12 who dropped out of school divided by the total number of students in grades 9-12;
- Promotion The number of students promoted to a higher grade or graduated divided by the number of students participating in the program;
- Attendance The number of students missing 10 percent or more of school days divided by the number of students participating in the program; and
- Discipline The number of students suspended for more than ten days or expelled divided by the number of students participating in the program.

#### Graduation Rate – Students in Grade 12 Participating in DOP Programs

Of the 7,339 students in grade 12 who participated for 45 days or more of the actual length of program, 4,989 (68%) graduated with a high school diploma.

Exhibit 6 displays the percentage of students in grade 12 by program type who graduated with a high school diploma.

#### Dropout Rate – Students in Grades 9-12 Participating in DOP Programs

Of the 21,108 students in grades 9-12 who participated for 45 days or more of the actual length of program, 795 (3.7%) dropped out of school. 96.3 percent of students continued to pursue their program goals.

Exhibit 7 displays the percentage of students in grades 9-12 by program type who dropped out of school.



# **Measuring Student Outcomes by DOP Type**

The following information includes student outcome data for each of the following DOP program types: educational alternatives, disciplinary, dropout retrieval, alternative to expulsion, teenage parent and city/county jail. A student may participate in one or more programs in a year. The number of students in respective DOP programs (29,447) exceeds the total number of participants (28,947).

#### **Educational Alternative Programs**

In the 2023-24 school year, 18,509 students at all grade levels participated in educational alternative programs for at least 45 days or more of the actual length of program.

Educational alternative programs are designed for students who may be unmotivated or unsuccessful in traditional school settings. Students are identified as potentially dropping out of school based on retention, high absenteeism and failing grades.

Outcome data for students in educational alternative programs reveal the following (note that a student may count in one or more categories):

- 3,841 (73.4%) of 5,234 students in grade 12 graduated with a high school diploma;
- 444 (3.2%) of 13,875 students in grades 9-12 dropped out of school;
- 17,257 (93.2%) of 18,509 students were promoted to a higher grade;
- 10,414 (56.3%) of 18,509 students missed 10 percent or more school days; and
- 16 (0.1%) of 18,509 students were suspended for more than ten days or expelled.

#### **Disciplinary Programs**

In the 2023-24 school year, 4,212 students at all grade levels participated in a disciplinary program for 45 days or more of the actual length of program.

Disciplinary programs are designed to provide interventions for students who exhibit disruptive behavior in the traditional school environment, offering positive alternatives to suspension and expulsion.

Outcome data for students in disciplinary programs reveal the following (note that a student may count in one or more categories):

- 223 (71.7%) of 311 students in grade 12 graduated with a high school diploma;
- 60 (2.7%) of 2,222 students in grades 9-12 dropped out of school;
- 3,943 (93.6%) of 4,212 students were promoted to a higher grade;
- 2,775 (65.9%) of 4,212 students were missing 10 percent or more school days; and
- 13 (0.3%) of 4,212 students were suspended for more than ten days or expelled.

#### **Dropout Retrieval Programs**

In the 2023-24 school year, 3,095 students at all grade levels participated in a dropout retrieval program for at least 45 days of the actual length of program.

Dropout retrieval programs are designed for students who have officially dropped out of school, re-enrolled and are persevering towards graduation with a primary focus on credit recovery and career planning.

Outcome data for students in dropout retrieval programs reveal the following (note that a student may count in one or more categories):

- 530 (42.6%) of 1,244 students in grade 12 graduated with a high school diploma;
- 177 (6.3%) of 2,810 students in grades 9-12 dropped out of school;
- 1,851 (59.8%) of 3,095 students were promoted to a higher grade;
- 1,825 (59%) of 3,095 students missed 10 percent or more school days; and
- No students were suspended for more than ten days or expelled.

#### Alternative to Expulsion

In the 2023-24 school year, 2,773 students at all grade levels participated in an alternative to expulsion program for at least 45 days of the actual length of program.

Alternative to expulsion programs are designed for students subject to district school board policies for expulsion due to repeated or serious offenders.

Outcome data for students in alternative to expulsion programs reveal the following (note that a student may count in one or more categories):

- 151 (75.5%) of 200 students in grade 12 graduated with a high school diploma.
- 56 (3.4%) of 1,647 students in grades 9-12 dropped out of school;
- 2,481 (89.5%) of 2,773 students were promoted to a higher grade;
- 1,752 (63.2%) of 2,773 students missed 10 percent or more school days; and
- 7 (0.3%) of 2,773 students were suspended for more than 10 days or expelled.

#### **Teenage Parent Programs**

In the 2023-24 school year, 564 teenage parents at all grade levels participated in a teenage parent program for at least 45 days of the actual length of program.

Teenage parent programs are designed for students who are pregnant or parenting, allowing them to continue their academic courses while receiving information on child growth and development, nutrition and parenting skills. Ancillary services, including health, social, childcare and transportation are provided to meet the specific needs of pregnant or parenting students and their children. Outcome data for students in teenage parent programs reveal the following (note that a student may count in one or more categories):

- 205 (78.5%) of 261 students in grade 12 graduated with a high school diploma;
- 15 (2.8%) of 536 students in grades 9-12 dropped out of school;
- 533 (94.5%) of 564 students were promoted to a higher grade;
- 466 (82.6%) of 564 students missed 10 percent or more school days; and
- No students were suspended for more than ten days or expelled.

#### **City or County Jail Programs**

In the 2023-24 school year, 294 students at all grade levels participated in a city or county jail program for 45 days or more of the actual length of program.

City or county jail programs are designed to provide educational services for students detained in a county or city detention facility.

Outcome data for students in city or jail programs reveal the following (note that a student may count in one or more categories):

- 39 (44%) of 89 students in grade 12 graduated with a high school diploma.
- 43 (16%) of 269 students in grades 9-12 dropped out of school;
- 263 (89.5%) of 294 students were promoted to a higher grade;
- 62 (21.1%) of 294 students missed 10 percent or more school days; and
- No students were suspended for more than ten days or expelled.

#### **Concluding Comments**

The Bureau of School Improvement will continue to ensure students have access to innovative programs aligned with the Florida Department of Education's vision to enhance students' opportunities for access, advancement and achievement.
