1. In order to identify if the "certification is fundable on a year's CAPE FCS fundable list," reference the appropriate txt file:

- INDCERT.2024.TXT
- INDCERT.2025.TXT

These files are on CCTCMIS website <u>here</u>. Look to the FUND column (not the CAPE column). If FUND='Y' then this industry certification is *eligible* for funding if the test date is in that year.

The online version of the reference file does not have column headers. For reference, an example is below:

- 2. In order to report valid Course ICS¹ records, Continuing Workforce Education, Adult General Education and Life Long Learning are excluded. Valid Course ICS records include:
 - Advanced and Professional,
 - Postsecondary Vocational,
 - Postsecondary Adult Vocational/Career Certificate,
 - A Class Course in the Apprenticeship ICS (1.29.97),
 - Apprenticeship On the Job Training (1.29.98), or
 - Educator Preparation Institute
- Note that students *must* be enrolled in one or more valid courses during the approved timeframe (see Exhibit 1).
