Current Accountability Tasks


• Survey 2 for Accountability Review Process: Weekly files are provided during amendment window. Corrections to data should be made in the survey data. Survey 2 closes December 15th.

Graduation Rate Cohort Corrections:

Web application that serves as final review and/or corrections of data to be used in the calculation of the graduation rate. Opening and closing dates to be determined.



2024-25 School Grades Results





Overall 2024-25 School Performance

- 71% of all schools earned an "A" or a "B" in 2024-25 compared to 64% in 2023-24.
- Approximately 2% of all schools earned a "D" or an "F" in 2024-25 compared to over 3% of schools in 2023-24.
- Reflecting the across-the-board improvement in assessment results in 2024-25, there were improvements in school grades for all school types (elementary, middle, high and combination).

School Grades Escalator Clause

- The school grading scales for high schools and combination schools have been adjusted upward for the 2025-26 school year, as more than 75% of schools in each of these categories earned a grade of "A" or "B" in the 2024-25 academic year.
- Because the district grading scale aligns with the combination school grading scale as required in Rule 6A-1.09981(5), Florida Administrative Code, the district grading scale has also been adjusted upward for the 2025-26 school year.

School Improvement Rating 3-Year Aggregate

- 2025-26 is the first year since transition to the new standards where three years of learning gains data will be available.
- If a school does not have enough data for at least one component in the current year, the data for that school will be aggregated using the current year and the two most recent years of data.



Senate Bill 1402 (2025)

- Defined dropout retrieval programs as programs that, "serve students who have officially withdrawn from high school before graduation and who are not engaged in the education system at the time of enrollment in the program."
- A virtual instruction program (VIP) provider operating exclusively as a dropout retrieval program as described in section 1003.53(7), Florida Statutes, is exempt from the district grade requirement.



House Bill 1105 (2025)

- Eliminated the certificate of completion previously available to students who earned the required credits to graduate but did not meet grade point or assessment standards.
- Were reported for the last time on Survey 5 for the 2024-25 school year.



Value-Added Models (VAM)

- In 2025-26, the three-year aggregate will include up to three consecutive years of data.
 - Three years of data over a three-year span:
 - 2023-24, 2024-25 and 2025-26.
