

The district-level results provided in this report address Indicator 8 of the State Performance Plan: “Percent of parents with a child receiving special education services who report that schools facilitated parent involvement as a means of improving services and results for children with disabilities.” The two columns that are bolded show the percentage of surveys returned and the percentage of survey responses that met or exceeded the state-designated standard for agreement.

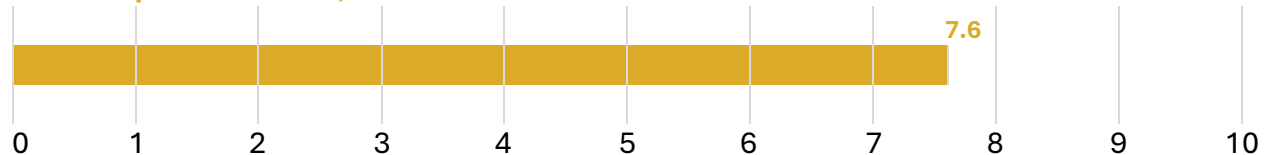

I understand the written information I receive from the school about my child's education.	84%
My child's Individual Educational Plan (IEP) addresses my child's development and describes progress towards goals.	83%

I am considered a valued partner to personnel in the planning and support of my child's program.	80%
I am offered a variety of ways to communicate with available staff.	78%
I am provided with the support I need to play an active role in my child's education.	76%
The school provides my child with all the services, accommodations and modifications documented on his/her IEP.	75%
I know what options I have if I disagree with the decision of the IEP team.	72%
School personnel provide me with information on agencies and information that can assist my child in the transition from school.	70%
School personnel discuss options for work or continuing education after high school.	68%

District: All / Satisfaction Score

The satisfaction score measures overall parent satisfaction with their child's special education on a scale of 0 through 10 (with 10 being very satisfied, and 0 being not at all satisfied.) This score represents the average satisfaction rating across all survey respondents. Higher scores indicate greater overall parent satisfaction with special education services and support.
